### 1.4. Treasurer's Report

Matt Dostal was not present and is stepping down as both Treasurer and Board member. Current funds on hand total \$35,226.40. Mark Goldstein, Secretary will temporarily take over Treasurer duties and responsibilities until a new Treasurer is elected this coming March-April. There was some additional discussion about whether the land line phone could be converted to Google or other VoIP phone service and whether a separate Zoom account, paid or unpaid, should be sought separate from the shared account with GAZEL.

### 1.5. ATIC Board Membership

There was continued discussion that we should target more membership from the telecom provider community, both wired and wireless. As part of our focus on expanding representation from the rural economic development community, Bill Bolin has contacted Tom Belshe, Deputy Director, League of Arizona Cities and Towns who recommends David Walsh, CEO of Sun Corridor get involved.

Mike Keeling to have discussions with Michael Sherman, now leading the Sun Corridor Network initiative and Mike Golden of Gigaband regarding potential Board membership. Steve Peters to approach Robert McArthur of the University of Arizona and Mark Goldstein to approach Fred Estrella, CIO of NAU regarding potential Board membership. Morgan Reed has been appointed ADOA-ASET CIO and should be engaged to participate in ATIC and potentially serve on the Board.

Mark Goldstein, Secretary to update the Board Roster and distribute for review and finalization.

1.6. Review of Outstanding Action Items as Documented in October 2015 Minutes.

Baseline budget development complete. Brenda Beall, Vice Chair will solicit ideas on investment of working capital on projects and coordinate with Strategy Committee.

## 2. Presentations and Action Plans

### 2.1. Cyber Security Public Meeting

Jerry Crow has coordinated a great program with our perennial partner Arizona InfraGard for the our fifth annual Cyber Security Summit planned for Thursday, November 19<sup>th</sup> from 1:00-4:30 PM at the University of Phoenix offices in Phoenix. Speakers will include: Jerry Proctor, Former Deputy to the Commanding General, US Army Intelligence Center and Ft Huachuca, Retired, Inspector William Long, Director, AZ Counter Terrorism Information Center (ACTIC), and Tina Slankas, Cybersecurity Coordinator, ACTIC. Frank Grimmelmann will moderate a panel discussion with Cody Cornell, CEO, Swim Lane, Sean Moshir, CEO/Chairman, CellTrust, and Andrew Roberts, Director, IT Compliance & Risk Management, Grand Canyon University.

### 2.4. Sun Corridor Update - (Janet Major)

Janet Major attended the recent Sun Corridor day-long meeting and reported on the presentations and progress. Michael Sherman is now leading the Sun Corridor Network initiative.

## 2.5. Apache County - (Galen Updike and Henry Goldberg)

Galen Updike organized a meeting in Eager, Apache County on regional broadband issues on November 3<sup>rd</sup>. Henry Goldberg provided an information document on Kit Carson Electric Cooperative and their fiber to the user programs and led a brief discussion of grant opportunities.

## 2.6. Education Proposal - Dropped from ATIC Consideration

Robert Backie, ATIC Chair had previously put forth a proposal that ATIC partner with others to produce a study on software skills needed for today and tomorrow's Arizona workforce to meet the needs of industry, especially in the entrepreneurial community. Mark Goldstein provided some 8-9 relevant IT skills and salaries studies, though mostly national in scope. Robert has decided that such a study by ATIC would be resource intensive and not in our best interests at this time.
